Walcott's miscellaneous satirical essays. The volume editor Gordon Collier has written a searching introductory essay on a central theme – here, a critical, comparative analysis of Walcott's development as journalist against the historical background of press activity in the Caribbean, coupled with an illustrative discussion (drawing on Walcott's newspaper articles) of his attitudes towards prose fiction and poetry.
