This book is an introductory text on magnetohydrodynamics (MHD) - the study of the interaction of magnetic fields and conducting fluids.

Essentials of Electromagnetics for Engineering, first published in 2000, provides a clearly written introduction to the key physical and engineering principles of electromagnetics. If the students have had a previous exposure to Electromagnetic theory, all the material can be reasonably covered in two semesters. Neophytes should probably spend a semester on the first four or five chapters as well as, depending on their mathematical background, the Appendices B to F. For a shorter or more elementary course, the material on spherical waves, waveguides, and waves in anisotropic media may be omitted without loss of continuity.
