The Manual of Tests and Criteria contains criteria, test methods

and procedures to be used for classification of dangerous goods according to the provisions of Parts 2 and 3 of the United Nations Recommendations on the Transport of Dangerous Goods, Model Regulations, as well as of chemicals presenting physical hazards according to the Globally Harmonized System of Classification and Labelling of Chemicals (GHS). As a consequence, it supplements also national or international regulations which are derived from the United Nations Recommendations on the Transport of Dangerous Goods or the GHS. At its ninth session (7 December 2018), the Committee adopted a set of amendments to the sixth revised edition of the Manual as amended by Amendment 1. This seventh revised edition takes account of these amendments. In addition, noting that the work to facilitate the use of the Manual in the context of the GHS had been completed, the Committee considered that the reference to the "Recommendations on the Transport of Dangerous Goods" in the title of the Manual was no longer appropriate, and decided that from now on, the Manual should be entitled "Manual of Tests and Criteria".

Where the book is quantitative, of course there are lots of formulae, but in general the author avoids vague notation and long derivations.

In displacement ventilation systems, the principle of buoyancy is utilised to remove warm contaminated air from an occupied area. The main driving force is natural convection: instead of attempt-

ing to combat the forces of natural convection as in mechanical dilution ventilation, displacement systems supply and exhaust air in such a way as not to interfere with the convection currents set up by the heat sources in a space. Provided that pollution and heat sources are in close proximity, displacement ventilation can give better air quality than dilution ventilation, but good design is necessary to ensure that unacceptable vertical temperature gradients and cold draughts along the floor are avoided.
