The main provision of this Bill is to enable regulatory reform. It extends the deregulation order-making power under Sections 1-4 of the Deregulation and Contracting Out Act 1994 (DCOA). Ministers

will be able to put orders to Parliament amending burdensome primary legislation. Ministers will be able to use orders to remove or reduce burdens contained in legislation, to correct inconsistencies and anomalies, and, in certain strictly defined circumstances, app-

ly new burdens. The Bill will also replace the bureaucratic enforcement provisions under section 5 of DCOA with a more flexible power. The new power will allow Ministers (and the National Assembly for Wales, where appropriate) to set out a code of good enforcement practice.
