The Soviet Union was the largest state in the twentieth-century world, but its repressive power and terrible ambition were most clearly on display in Europe. Under the leadership of Joseph Stalin, the Soviet Union transformed itself and then all of the European countries with which it came into contact. This volume considers each aspect of the encounter of Stalin with Europe: the attempt to create a kind of European state by accelerating the European model of industrial development in the USSR; mass murder in anticipation of a war against European powers; the actual contact with Europe's greatest power, Nazi Germany, first as ally and then as enemy; four years of war fought chiefly on Soviet territory and bringing untold millions of deaths, including much of the Holocaust; and finally the reestablishment of the Soviet system, not just in prewar territory of the USSR, but in Western Ukraine, Western Belarus, the Baltic States, Poland, Czechoslovakia, Romania, Hungary, Bulgaria, and East Germany.

It can seem as though the Cold War division of Europe was inevitable. But Stalin was more open to a settlement on the continent than is assumed. In this powerful reassessment of the postwar order, Norman Naimark returns to the four years after WWII to illuminate European leaders' efforts to secure national sovereignty amid dominating powers.

Did Japan surrender in 1945 because of the death and devastation caused by the atomic bombs dropped by the Americans on Hiroshima and Nagasaki or because of the crushing defeat inflicted on their armies by the Soviet Union in Manchukuo, the puppet state they set up in north-east China? Indeed, the Red Army's rapid and total victory in Manchukuo has been relatively neglected by historians. Charles Stephenson, in this scholarly and highly readable new study, describes the political, diplomatic and military build-up to the Soviet offensive and its decisive outcome. He also considers to what extent Japan's capitulation is attributable to the atomic bomb or the stunningly successful entry of the Soviet Union into the conflict. The German invasion of the Soviet Union on June 22, 1941, began a war that lasted nearly four years and created by far the bloodiest theater in World War II. In the conventional narrative of this war, Hitler was defeated by Stalin because, like Napoleon, he underestimated the size and resources of his enemy. In fact, says historian John Mosier, Hitler came very close to winning and lost only because of the intervention of the western Allies. Stalin's great triumph was not winning the war, but establishing the prevailing interpretation of the war. The Great Patriotic War, as it is known in Russia, would eventually prove fatal, setting in motion events that would culminate in the collapse of the Soviet Union. Deathride argues that the Soviet losses in World War II were unsustainable and would eventually have led to defeat. The Soviet Union had only twice the population of Germany at the time, but it was suffering a casualty rate more than two and a half times the German rate. Because Stalin had a notorious habit of imprisoning or killing anyone who brought him bad news (and often their families as well), Soviet battlefield reports were fantasies, and the battle plans Soviet generals developed seldom responded to actual circumstances. In this respect the Soviets waged war as they did everything else: through propaganda rather than actual achievement. What saved Stalin was the Allied decision to open the Mediterranean theater. Once the Allies threatened Italy, Hitler was forced to withdraw his best troops from the eastern front and redeploy them. In addition, the Allies provided heavy vehicles that the Soviets desperately needed and were unable to manufacture themselves. It was not the resources of the Soviet Union that defeated Hitler but the resources of the West. To eradicate those regarded as "enemies of the working class," Stalin instituted the "Great Purge" in which over a million were imprisoned and at least 700,000 were executed from 1934 to 1939. In 1939 Stalin's government signed a non-aggression pact with Nazi Germany. Germany ended the pact by invading the Soviet Union in 1941. The Soviet Red Army halted the German incursion and captured Berlin in 1945, ending World War II in Europe.

The orthodox view of Vyacheslav Molotov is that he was no more than Stalin's faithful servant, a dogmatic communist, and a conservative hard-liner of little or no imagination. Molotov was, indeed, Stalin's right-hand man; from the 1920s to the early 1950s the two men presided over a brutal, authoritarian communist system that resulted in the deaths of millions of people. But there was far more to their partnership. In this engaging biography, Geoffrey Roberts proposes a radical reappraisal of Molotov's life and career. He argues that although Molotov, as Soviet foreign minister since 1939, was certainly Stalin's cold warrior, he personally preferred détente and peaceful coexistence with the West. The differences and tensions between Molotov and Stalin came to a head in 1949, when Molotov's wife was arrested and imprisoned because of her involvement with the Soviet Jewish Anti-Fascist Committee. Molotov was removed as foreign minister but was reappointed to the post after the dictator's death in 1953. In 1957 Molotov was ousted from the leadership following his attempted coup against Nikita Khrushchev, Stalin's successor as the leader of the Soviet Communist Party. After Stalin's death, Molotov revived his efforts to curtail the Cold War and campaigned for the establishment of a pan-European system of collective security that would halt the polarization of the continent into competing military-political blocs. While Molotov's attempt to negotiate an end of the Cold War were stymied by Soviet and Western hard-liners, his campaign for European collective security paved the way to détente in the 1960s and 1970s and the abolition of the Cold War in the 1980s and 1990s.

On June 22, 1941, just less than two years after signing the Nazi-Soviet Agreements, Adolf Hitler's German army invaded the Soviet Union. The attack hardly came as a surprise to Josef Stalin; in fact, history has long held that Stalin spent the two intervening years building up his defenses against a Nazi attack. With the gradual declassifying of former Soviet documents, though, historians are learning more and more about Stalin's grand plan during the years 1939-1941. Longtime Soviet expert Albert L. Weeks has studied the newly-released information and come to a different conclusion about the Soviet Union's pre-war buildup—it was not precaution against German invasion at all. In fact, Weeks argues, the evidence now suggests Soviet mobilization was aimed at an eventual invasion of Nazi Germany. Just as Powell's *FDR's Folly* exploded the myths about Franklin Roosevelt and the New Deal, *Wilson's War* destroys the conventional image of Woodrow Wilson as a great “progressive” who showed how the United States can do good by intervening in the affairs of other nations.
