This volume describes African cities in transition, and the economic, socio-political, and environmental challenges resulting from rapid post-colonial urbanization. As the African continent continues to transition from urban configurations inherited from colonial influences and history, it faces issues such as urban slum expansion, increased demands for energy and clean water, lack of adequate public transportation, high levels of inequality among different socio-economic population strata, and inadequate urban governance, planning, and policies. African cities in transition need to reconsider current policies and developmental trajectories to facilitate and sustain economic growth and Africa's strategic repositioning in the world. Written by an international team of scholars and practitioners, this volume uses case studies to focus on key issues and developmental challenges in selected African cities. Topics include but are not limited to, smart cities, changing notions of democracy, the city's role in attaining the SDGs, local governance, alternative models for governance and management, corruption, urbanisation and future cities.

The contributions in this volume offer a comprehensive analysis of transitional justice from 1945 to the present. They focus on retribution against the leaders and agents of the autocratic regime preceding the democratic transition, and on reparation to its victims. Part I contains general theoretical discussions of retribution and reparation. The essays in Part II survey transitional justice in the wake of World War II, covering Austria, Belgium, Denmark, France, Germany, Hungary, the Netherlands, and Norway. In Part III, the contributors discuss more recent transitions in Argentina, Chile, Eastern Europe, the former German Democratic Republic, and South Africa, including a chapter on the reparation of injustice in some of these transitions. The editor provides a general introduction, brief introductions to each part, and a conclusion that looks beyond regime transitions to broader issues of rectifying historical injustice.

This book provides an important compilation and synthesis of current work in transition to school research. This book is based on workshops held in Mexico (2012) and in the US (2013), on a winter school at Chulalongkorn University, Thailand (2013), and on commissioned chapters. The workshop in Mexico and the publication were supported by two grants by the German Foundation for Peace Research (DSF). All texts in this book were peer-reviewed by scholars from all parts of the world.

This edited volume presents and reflects upon empirical evidence of 'sustainability'-induced and -related transition in food practices. The material collected in the various chapters contributes to our understanding of the ways in which ideas and preferences, sociotechnological developments and changes in the governance of food interact and become visible in practices of consumption, retail and production.

This book examines the kinds of transitions that have been studied in mathematics education research. It defines transition as a process of change, and describes learning in an educational context as a transition process. The book focuses on research in the area of mathematics education, and starts out with a literature review, describing the epistemological, cognitive, institutional and sociocultural perspectives on transition. It then looks at the research questions posed in the studies and their link with transition, and examines the theoretical approaches and methods used. Crucial reading for academics and practitioners of urban planning and sustainability in Europe, *Cities in Transition* is an innovative roadmap for sustainability in changing cities.

By the 30th anniversary of the fall of the Berlin Wall, in most parts of Eastern Europe, high expectations associated with postsocialist transition have been substituted by disillusionment. After 1990, Eastern Europe has been internationally treated with a low-interest acknowledgement of what was

understood as a slow and erratic, but unquestionable process of integration in a Western-dominated world order. In the context of today's geopolitical reorganization, East European examples of authoritarian politics once again become discussed as significant reference points for Western and global politics. This book represents a contribution to this debate from a distinctive East European perspective: that of new left scholars and activists from the region, whose lifetime largely corresponds to the transformations of the postsocialist period, and who came to develop an understanding of their environment in terms of its relations to global capitalist processes. A both theoretical and empirical contribution, the book provides essential insights on topics conventionally associated with East European transition from privatization to the politicized slogans of corruption or civil society, and analyzes their connection to the newest reconfigurations of postsocialist capitalist regimes. As a contribution to contemporary debates on the present global socio-political transformation, this collection does not only seek to debate analytical statements, but also to change the field where analytical stakes are set, by adding perspectives that think Eastern Europe's global relations from within the regional context and its political stakes. Agnes Gagyi works on East European politics and social movements from the perspective of the regions long-term global integration. She is researcher on East European social movements at the University of Gothenburg, and member of the Working Group for Public Sociology Helyzet in Budapest. Ondrej Slacalek is a political scientist and journalist, he focuses on East European politics, nationalism and social movements. He works at Charles University, Prague. He is a regular collaborator of Czech new left journal *A2/A2*arm.

This book provides an updated and fresh introduction to recent theoretical developments in youth studies. It expands upon these developments and introduces new discussions and perspectives. It presents three central theoretical traditions in youth studies, and explores the possibilities of re-defining some of the central concepts, but also of combining different theoretical perspectives. After depicting the theoretical landscape of youth studies, the book explores generations and new subjectivities. Before presenting its conclusions, the book delves into the development of youth studies, theory and everyday life. All together the book taps into what is happening in the everyday lives of young people, and employs a methodology that can be used to create bridges between young people's voices and experiences on the one hand and societal and cultural transformations on the other.

TV Drama in Transition reflects upon changing dramatic forms on television in the context of broad cultural shifts over the past two decades. Analyses of a wide range of series (from *Heartbeat* to *Middlemarch* and *Our Friends in the North*; from *NYPD Blue* to *Twin Peaks* to *The X-Files*) are interspersed with accounts of new technologies, viewing dispositions and the political economy of culture. This book is generally concerned as much with the condition of culture in the 1980s and 1990s, as specifically with TV drama.

This open access book maps the youth transitions of descendants of migrants from Turkey living in Amsterdam and Strasbourg, through a comparative mixed-methods research design. As such, it is of interest to discussions in youth sociology, social mobility and second-generation research. The book follows transition trajectories of the second-generation, from school to activity or inactivity in the labour market, to marriage or further study and, deepens our understanding of transitions by unravelling the macro and micro mechanisms behind individual pathways. On the one hand, the author reveals the ongoing significance of distinct macro institutional settings as well as social structures such as social class, ethnicity and gender in shaping the youth transition experience. On the other, she shows that youth transitions are not predestined to social reproduction when institution-

al and social structures create conditions for the development of resources necessary for social mobility. Therefore, through an examination of how immigrants' descendants develop forms of capital in their social trajectories, in relation to institutional and social structures, the book advances the theoretical discussion on Bourdieu's capital theory. Moreover, in times when native-born descendants of immigrants are at the forefront of public debate being subjected to normative integration demands, the book significantly shifts the lens and draws our attention to the daily challenges and realities faced by ethnic minority youth.

*Transitional Justice and Civil Society in the Balkans* covers civil society engagements with transitional justice processes in the Balkans. The Balkans are a region marked by the post-communist and post-conflict transitional turmoil through which its countries are going through. This volume is intended to provide a comprehensive introduction to research in transitional justice in this part of the world, mostly written by local scholars. Transitional justice is ever-growing field which responds to dilemmas over how successor regimes should deal with past human rights abuses of their authoritarian predecessors. Ryan argues that there have been four dramatic transitions in Jordan's recent past: ambitious economic restructuring; efforts toward political liberalization; realignments in foreign relations (culminating in the 1994 peace agreement with Israel); and the succession of King Abdullah II. Exploring these transitions, and how each in turn affects the others, he provides a major contribution to our understanding of Jordan.

China's 30-year market transition and its integration into the world economy provide a unique opportunity for exploring the nature of large-scale economic and political transformation and the mechanisms underlying organizational behavior during such a transition. *Management and Organizations in Transitional China* explores how managers and firms cope with transition-related challenges by adapting to, manipulating, or even creating the complex institutional environment. This book examines the way transitional institutions shape individual decisions and organizational strategies, the mechanisms that promote the diffusion of innovative management practices and economic policies, and the formation and evolution of interfirm networks. Combining theory, data analysis, and rich contextual description to provide a comprehensive understanding of the organizational transition process, this book will appeal to scholars and practitioners in general management, organizational studies, international business, entrepreneurship, and related disciplines.

This book contributes to current debates regarding purposive transitions to sustainable cities, providing an accessible but critical exploration of sustainability transitions in urban settings. We have now entered the urban century, which is not without its own challenges, as discussed in the preceding book of this series. Urbanization is accompanied by a myriad of complex and overlapping environmental, social and governance challenges – which increasingly call into question conventional, market-based responses and simple top-down government interventions. Faced with these challenges, urban practitioners and scholars alike are interested in promoting purposive transitions to sustainable cities. The chapters in this volume contribute to the growing body of literature on city-scale transformative change, which seeks to address a lack of consideration for spatial and urban governance dimensions in sustainability transitions studies, and expand on the basis established in the preceding book. Australia is on the one hand representative of many OECD countries, while on the other possessing a number of unique attributes that may serve to highlight issues and potentials internationally. Australia is a highly urbanized country and because of the federal political structure and the large distances, the five largest state-capital cities have a relatively high degree of autonomy in governance – even dominating the rest of their respective states and rural hinterlands to a certain extent. This context suggests that Australian cases can provide interesting “test-tube” perspectives on processes relevant to urban sustainability transitions worldwide. This volume presents an extensive overview of theories, concepts, approaches and practical examples informed by sustainability transitions thinking, offering a unique resource for all urban practitioners and scholars who want to understand and transition to sustainable urban futures.

Diwan and Galal looks at the structure and prospects of the Middle East economies after the 2011 Uprisings, focusing on issues of economic growth, inequality, the impact of oil, and the unfolding political transitions. On the growth question, the book looks into the extent of structural transformation of the economy, the political economy reasons for the lack of structural change, and the external conditions in the EU and in the GCC that underpin the lack of structural change. On inequality, the book offers new measures of equality of opportunity in human development and in the job market, and it also reviews the complex political economy of subsidy removal. Regarding natural resources, the volume provides three innovations: connecting the notion of ‘oil curse’ to the global phenomena of asset bubbles; evidence that resource curse effects do not rise monotonically with the size of the resource rent, but rather, according to an inverted U shape; and an extension of the concept of rent to the other non-oil rents that are also predominant in the region. Finally, the volume places the political transition in the region in a global perspective using various methods – theoretical, comparative, and empirical, and it explores the relationship between democracy in its variety of forms and economic development.

This Open Access book presents feedback from the 'Territorial Agroecological Transition in Action'-TATA-BOX research project, which was devoted to these specific issues. The multidisciplinary and multi-organisation research team steered a four-year action-research process in two territories of France. It also presents: i) the key dimensions to be considered when dealing with agroecological transition: diversity of agriculture models, management of uncertainties, polycentric governance, autonomies, and role of actors' networks; ii) an operational and original participatory process and associated boundary tools to support local stakeholders in shifting from a shared diagnosis to a shared action plan for transition, and in so doing developing mutual understanding and involvement; iii) an analysis of the main effects of the methodology on research organisation and on stakeholders' development and application; iv) critical analysis and foresights on the main outcomes of TATA-BOX, provided by external researchers.

Focusing on the growing power of transnational media corporations in an increasingly globalized environment for distribution of television content, and on the effects of mergers and acquisitions involving local and independent television production companies, this book examines how current and recent re-structurings in ownership across the television industry reflect changing business models, how they affect creativity and diversity of television output, and to what extent they call for new approaches to regulation and policy. The book draws on a range of theoretical frameworks and research projects to provide multiple perspectives of family involvement in education, family-educator partnerships, the nature of collaboration, issues for families in marginalised or complex circumstances, as well as the multiple intersections of families and transition processes. The research projects reported range from in-depth case studies to the analysis of large-scale data sets and all have multiple messages for practitioners, policy makers and researchers as they seek ways to engage with families as their children start school.

Not since Marx identified the manufacturing plants of Manchester as the blueprint for the new capitalist society has there been a more profound transformation of the fundamentals of our social life. As capitalism faces a series of structural crises, a new social, political and economic dynamic is emerging: peer to peer. What is peer to peer? Why is it essential for building a commons-centric future? How could this happen? These are the questions this book tries to answer. Peer to peer is a type of social relations in human networks, as well as a technological infrastructure that makes the generalization and scaling up of such relations possible. Thus, peer to peer enables a new mode of production and creates the potential for a transition to a commons-oriented economy.

This book investigates the potential contribution that a strategic design approach can make to stimulating and supporting the societal embedding of sustainable PSSs (product-service systems). A new strategic design role thus emerges; a role in which the ideation and development of sustainable PSS concepts is coupled with the designing of appropriate transition paths (sequence of socio-technical experiments) to gradually incubate, introduce and diffuse these concepts. The book also outlines the new design approach and capabilities needed by strategic designers, project managers and consultants to operate at such a strategic level. On a more operational point of view, the work presents a practical "how to do" design process and associated guidelines to support practitioners in designing and managing the societal embedding process of sustainable PSS innovations.
